- Differentiate between recyclable and non-recyclable waste
- State the importance of using appropriate colour dustbins for different types of waste.
- Discuss common practices for conserving electricity at workplace.
- Discuss the common sources of pollution and ways to minimize it.

<ul style="list-style-type: none"> • Discuss how to collect the information from supervisor about the packing/unpacking tasks and work requirements. • Describe methodology for packing goods as per size , BOM. • List packing/ unpacking requirements such as packing material i.e. boxes, trolleys, strapping etc. • Discuss the safety practices to avoid any hazard and accident during packing/unpacking work. • List the steps to be performed for packing and unpacking the material safely. • Discuss the need and ways of packing and unpacking the spare parts, kits and export material with extra care. • Discuss ways to check moisture, oil, dust and any foreign material on the parts. • List the steps to be performed for releasing the material to Stores/QC/ Shipping as per the documentation. • List the commercial documents required for each type of consignment as per the checklist and organisational guidelines. 	<ul style="list-style-type: none"> • Role play a situation on co-ordinating with supervisor for confirming packing/unpacking tasks and work requirements. • Show how to inform supervisor about the packing/ unpacking requirements. • Demonstrate the use of packing material for packing of the automotive spare parts, components etc. • Role play a situation on co-ordinating with the central planning department for timely receipt of materials need to pack or unpack. • Perform the organisational specified procedure of packing and unpacking the material as per WI, BOM and other applicable documentation. • Role play a situation on co-ordinating with stores to determine the availability of materials in the inventory. • Show how to count and tally the quantity of material on releasing document and hand over the material to Stores/QC/ Shipping. • Show how to check the defects and damages in the material. • Perform steps to report or convey about any damage material identified or damage done during packing and unpacking to the supervisor or appropriate person. • Apply appropriate ways to check the trolleys/ boxes as per the organisational guidelines and WI. • Perform steps to report or convey about issues in trolleys/ boxes used for carrying material.

Assessment Strategy

1. Assessment System Overview:
 - Batches assigned to the assessment agencies for conducting the assessment on SDMS/SIP or email
 - Assessment agencies send the assessment confirmation to VTP/TC looping SSC
 - Assessment agency deploys the ToA certified Assessor for executing the assessment
 - SSC monitors the assessment process & records
2. Testing Environment:
 - Confirm that the centre is available at the same address as mentioned on SDMS or SIP
 - Check the duration of the training.
 - Check the Assessment Start and End time to be as 10 a.m. and 5 p.m.
 - If the batch size is more than 30, then there should be 2 Assessors.
 - Check that the allotted time to the candidates to complete Theory & Practical Assessment is correct.
 - Check the mode of assessment—Online (TAB/Computer) or Offline (OMR/PP).
 - Confirm the number of TABs on the ground are correct to execute the Assessment smoothly.
 - Check the availability of the Lab Equipment for the particular Job Role.
3. Assessment Quality Assurance levels / Framework:
 - Question papers created by the Subject Matter Experts (SME)
 - Question papers created by the SME verified by the other subject Matter Experts
 - Questions are mapped with NOS and PC
 - Question papers are prepared considering that level 1 to 3 are for the unskilled & semi-skilled individuals, and level 4 and above are for the skilled, supervisor & higher management
 - Assessor must be ToA certified & trainer must be ToT Certified
 - Assessment agency must follow the assessment guidelines to conduct the assessment
4. Types of evidence or evidence-gathering protocol:
 - Time-stamped & geotagged reporting of the assessor from assessment location
 - Centre photographs with signboards and scheme specific branding
 - Biometric or manual attendance sheet (stamped by TP) of the trainees during the training period
 - Time-stamped & geotagged assessment (Theory + Viva + Practical) photographs & videos
5. Method of verification or validation:
 - Surprise visit to the assessment location
 - Random audit of the batch
 - Random audit of any candidate
6. Method for assessment documentation, archiving, and access
 - Hard copies of the documents are stored
 - Soft copies of the documents & photographs of the assessment are uploaded / accessed from Cloud Storage
 - Soft copies of the documents & photographs of the assessment are stored in the Hard Drives

Declarative Knowledge	Declarative knowledge refers to facts, concepts and principles that need to be known and/or understood in order to accomplish a task or to solve a problem.
Key Learning Outcome	Key learning outcome is the statement of what a learner needs to know, understand and be able to do in order to achieve the terminal outcomes. A set of key learning outcomes will make up the training outcomes. Training outcome is specified in terms of knowledge, understanding (theory) and skills (practical application).
OJT (M)	On-the-job training (Mandatory); trainees are mandated to complete specified hours of training on site
OJT (R)	On-the-job training (Recommended); trainees are recommended the specified hours of training on site
Procedural Knowledge	Procedural knowledge addresses how to do something, or how to perform a task. It is the ability to work, or produce a tangible work output by applying cognitive, affective or psychomotor skills.
Training Outcome	Training outcome is a statement of what a learner will know, understand and be able to do upon the completion of the training.
Terminal Outcome	Terminal outcome is a statement of what a learner will know, understand and be able to do upon the completion of a module. A set of terminal outcomes help to achieve the training outcome.
